2015 - MAXIMUM HOME RENTS BY UNIT SIZE AND INCOME LIMIT RESTRICTIONS EFFECTIVE MARCH 25, 2015					
HOME has two different requirements when determining the maximum allowable HOME rents as follows:					
1) MAXIMUM RENTS IF UTILITIES ARE PAID BY THE PROPERTY OWNER: If the property owner pays the utilities, the maximum allowable HOME rents (including the owner paid utilities) may not exceed the amount indicated below for the appropriate number of bedrooms; or					
2) MAXIMUM RENTS IF UTILITIES ARE PAID BY THE TENANT(S): If the some or all of the utilities are paid by the tenant(s), the maximum allowable HOME rents plus utilities based on the "Utility Allowance Schedule" cannot exceed the amounts indicated below for the appropriate number of bedrooms.
