

“CLEAN SWEEP” NEIGHBORHOOD CLEAN-UP PROGRAM

The Code and Neighborhood Services Division is offering residents an opportunity to host a clean-up event in their neighborhood. Residents who are interested in being a Neighborhood Clean-up Coordinator can apply to the City to participate in this program. Large roll-off dumpsters will be provided free of charge for the day. In addition, residents will be able to utilize garden equipment that will be available in the City's clean-up trailer.

PROGRAM GUIDELINES

- For Moreno Valley residents only.
- A minimum of four (4) weeks advance notice is required to promote the event, obtain City approval and allow neighbors to prepare for the event.
- The Neighborhood Clean-up Coordinator must provide event information to their entire street or neighborhood.
- At least ten (10) households must participate.
- Neighborhoods will be eligible to schedule a clean-up event a maximum of once per calendar year.
- Clean-up events are not intended for individual use. Promotion of the program is necessary in order to be fair to all residents.
- The normal clean-up event will be Saturdays from 8:00 a.m. to noon.
- A maximum of two (2) 40-cubic yard dumpsters will be delivered at approximately 7:00 a.m. on the Saturday of your choice and picked up that same afternoon. In order to avoid illegal and hazardous material disposal dumpsters may not be left overnight.
- A Code Compliance Officer will be in attendance with the City's clean-up trailer. Residents may check out equipment such as lawn mowers, trimmers, etc., for use only on the day of the scheduled clean-up.
- Each resident will be limited to dumping a reasonable amount of materials. For example, a resident cannot use a free bin for a large rehabilitation or landscaping project.
- No liquid, hazardous waste or tires will be allowed.
- In order to avoid illegal dumping or misuse of the bins Volunteers must assist the Code Compliance Officer with monitoring them at all times during the event.

HOW TO APPLY

- Keep it out of the landfill/waste reduction. The Neighborhood Clean-up Coordinator should assess the material to be disposed of and make diversions if possible. For example, furniture, clothing, and other items may be diverted from the landfill by coordinating with local charities and thrift stores (many charitable organizations will pickup items on the day of your event with prior notice).
- Individuals interested in coordinating an event in their neighborhood should first contact the Code and Neighborhood Services Division at (951) 413-3340 to determine whether they are eligible for the program.
- Residents who have not been included in this program or other neighborhood clean-ups sponsored by the Code and Neighborhood Services Division during the previous year may submit an application. The application should also include the signatures and addresses of residents who will be participating in the event.
- The application is available at www.moreno-valley.ca.us/ or at City hall. It can be submitted in person, via mail or by fax.
- After the Code and Neighborhood Services Division has approved the application, the Neighborhood Clean-up Coordinator may begin promoting their program via door-to-door visits, phone calls, etc. A sample flyer is also available at the website listed above.
