## **RESEARCH REQUEST**

The official copy of the plans maintained by the City can be viewed only on the premises as a public record. Requests to make duplicate copies in whole or in part will require 1) written permission of the licensed professional or their successor, if any, who signed the plan $\diamond$ ; AND 2) written permission of the current property owner or association established to manage the property(ies) (**OR 3**) by court order or by any state agency. [Health & Safety Code Section 19851]

- ◆ The City shall request authorization from the licensed professional or their successor, if any, and wait approx. 30–60 days for a response prior to providing any copies of plans/documents.
- The requestor shall request authorization from the property owner or the association established to manage the property(ies).

Typical turn-around time is ten (10) business days; however, extensive requests may take longer dependent on staff workload. You will be notified via email when the research is complete and provided the invoice of fees due prior to releasing the documents. You must arrange with a local blueprint company for any reproduction services.

## RESEARCH FEE \* = \$170 per Hour / \$85.00 (1/2 Hr. minimum fee)

\* Research fee is for time spent performing the research, regardless of the results.

◆ ◆ Requests for any grading / erosion control plans should be submitted to the City Clerk's office using the PUBLIC RECORDS REQUEST FORM (DO NOT SUBMIT DIRECTLY TO LAND DEVELOPMENT).
