

# UTILITY USERS' TAX EXEMPTION

## Reduce Your Monthly Utility Costs

The City of Moreno Valley may be able to help qualifying households meet utility needs by reducing monthly utility costs. The Utility Users' Tax Exemption program may be able to help reduce costs by as much as 5.75%.

You may qualify for a Utility Users' Tax Exemption if the combined gross income of all members of your household is less than 65% of the median household income for the County of Riverside as defined by HUD.

### PROOF OF ANNUAL GROSS INCOME MUST BE PROVIDED - SEE BACK OF FORM CERTIFICATION

I Certify (or declare) under penalty of perjury, that:

1. I am a user of the utilities shown hereon at premises occupied by myself.
2. The combined gross income of all members of the household in which I reside is less than that specified as 65% of median household income for the County of Riverside as defined annually by HUD.
3. I will notify the City Treasurer within 10 days of any changes, which could affect my eligibility for this exemption.
4. I, the undersigned, hereby claim exemption from the utility users tax imposed by Chapter 3.26 of the Moreno Valley Municipal Code.

**Note:** The exemption will not take effect until this application has been verified and approved by the City of Moreno Valley and processed by the above Utilities. Ordinance #503 amending Title 3 of the City of Moreno Valley Municipal Code, chapter 3.26 makes it unlawful for any person to knowingly receive the exemption provided when such person does not meet the requirements. Misrepresentation is deemed a misdemeanor and subject to a fine of \$500 and/or imprisonment. The exemption is not retroactive and any taxes paid prior to the effective date will not be refunded. Exemption is valid only for account numbers shown above. If you move, a new application must be submitted. Renewal forms with proof of gross income must be submitted annually during the month of February.
