Form 2 – Diversion Report

- Complete and submit this form to the City of Moreno Valley. Write clearly and include copies of all receipts showing certified weights for materials that were recycled, reused, composted, salvaged, or disposed of (landfilled).
- All reported materials must be supported by legible, dated receipts showing certified weights. Submittals without required documentation will not be approved.

Reporting Weights

Convert all material weights to **tons** before entering values on this form.

- To convert pounds to tons, divide by 2,000

Box 1 – Total Diverted (tons):

Enter the total weight of all materials that were recycled, reused, composted, or salvaged

Box 2 – Total Landfilled (tons):

Enter the total weight of all materials that were disposed of (landfilled)

Box 3 – Total Waste Generated (tons):

Add Box 1 + Box 2 and enter the total.

Box 4 – Diversion Rate (%):

Divide Box 1 by Box 3 and enter the result as a percentage.
